Conditions for the use of Pleasanton Art League property:

- Equipment is available to PAL members, or organizations affiliated with PAL.
 - Equipment is to be used only at art related events.
 - Usual use period is 4 days. Rentals for longer than that require prior approval by the PAL President.
 - Using artist/renter is responsible for arranging with the PAL President for the pick-up and returns.
- PLEASE NOTE: Transportation and set-up of PAL's equipment is the sole responsibility of the Artist/Renter.** Equipment must be returned in the same condition as supplied, except for normal wear and tear. The cost of replacement for lost, or repair of damaged equipment is the sole responsibility of the using artist/renter. PAL President will make determinations.

Artist/Renter Fees: Art Exhibit Flats (size: 3x6 ft.)—\$2.00 per flat (including leg bases and cinch clips). Sandwich Board Signs or "A" Frame Stand Signs—\$5.00 per Sign. Foldable 6-foot Tables—\$7.00 per table.

Schedule of costs for items lost or damaged: Art Exhibit Plats, \$95.00each- 3 Leg Adjuster Plate, \$18.00- 1-2 Leg Adjuster Plate, \$15.00- Cinch Clips \$3.00- 3 Leg Base \$18.00- 1-2 Leg Base \$15.00- Hanging hooks \$1.00 per dozen- Thumb Screws \$1.00- Tables \$20.00. **A check in the amount of \$100.00 is required as a damage deposit. This will be returned (or destroyed) once the equipment has been returned undamaged.**

Using artist/renter agrees to hold PAL and its officers harmless for and against any and all loss, liability, expense, claim, costs, suits, and damages of every kind, nature, description, directly or indirectly arising from the conditions of this agreement and/or the use of any PAL equipment.
